## LANDLORD INTERIM BILLING SERVICE AGREEMENT

The undersigned is the owner/authorized agent of a house or apartment at:

It is my desire that Cheyenne Light, Fuel and Power leave its natural gas and/or electric served turned on even if the tenant or occupant, in whose name the service is metered, requests that such service be discontinued or the services are discontinued by Cheyenne Light, Fuel and Power pursuant to the Wyoming PSC rules and Regulations and Cheyenne Light, Fuel & Power Tariffs.

In consideration of Cheyenne Light, Fuel and Power doing so, I agree to pay for all electric/natural gas service provided to the property listed on this agreement in order to avoid a period of discontinuance of service by a tenant or occupant. My failure to pay may result in the immediate cancellation.

In case I sell the premises I agree to notify Cheyenne Light, Fuel and Power, in writing and until Cheyenne Light, Fuel, and Power receives such notification, I will assume liability as provided above. I also agree to notify Cheyenne Light, Fuel and Power in writing if I change my address or wish to cancel this agreement.

Cheyenne Light, Fuel and Power expressly reserves the right to disconnect service to a tenant for collection purposes pursuant to the Wyoming PSC Rules and Regulations and Cheyenne Light, Fuel and Power Tariffs. If services are to be disconnected, the services will revert to my name. I agree that I will be responsible for future billings, even if the tenant still occupies the premises. It is agreed by and between Cheyenne Light, Fuel and Power and the undersigned that in cases where a tenant is disconnected at the Company's option, the Company will use its best efforts to notify me of the disconnection.

**(IF SIGNED BY AUTHORIZED AGENT) THE UNDERSIGNED WARRANTS THAT HE/SHE IS THE AUTHORIZED AGENT FOR THE OWNER AND HAS AUTHORITY TO BIND THE OWNER TO THIS AGREEMENT.**

I AGREE THAT IT WILL BE MY RESPONSIBILITY TO NOTIFY CHEYENNE LIGHT, FUEL & POWER ("CLFP") WHEN AN ACCOUNT IS TO BE CHANGED FROM MY NAME TO A TENANT OR WHEN THERE IS CHANGE IN TENANTS (contact CLFP at 307-638-3361).

Further, I agree to notify CLFP within 30 days of any change to this agreement.
